  - e. Customer Support: To respond to your inquiries and provide customer support.
  - **f.** Improve Services: To analyze and improve our services, including the development of new programs and offerings.
  - **g.** Legal Compliance: To comply with legal and regulatory requirements, including reporting obligations to government agencies.

### 3. How We Protect Your Information

We take the security of your personal information seriously and employ reasonable administrative,

All other use case categories exclude text messaging originator opt-in data and consent; this information will not be shared with any third parties.
